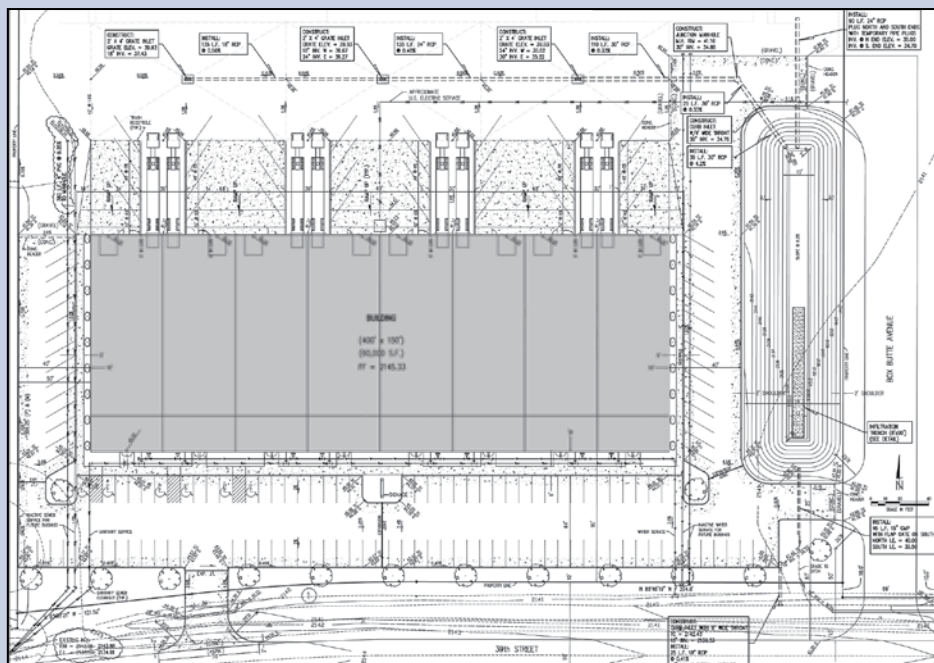

Description/Features.....	20,000 sq. ft. up to 60,000 sq. ft. steel building built in 2004 with 16' to 24' slope ceilings and 6" concrete floors, configurable space with options for multiple dock door access points and retail frontage
Land.....	Outside 100-year floodplain, 0% wetland
Zoning	M-1 Limited Industrial
Present Use	Distribution/Warehouse
Protective Services.....	Fire insurance rating (ISO) – City of Kearney – 2; Kearney is made up of a staff and volunteer fire department consisting of approximately 70 members. Nearest fire station is located 2.5 miles from the site.

Sanitary Sewer.....	City of Kearney; 24" main in Antelope Avenue, no lift required, secondary treatment plant with trickling filters, chlorination, and dechlorination has a rated capacity of 4.8 mgd with a 3.18 mgd average daily flow
Telecommunications.....	Frontier Communications; digital central office on fiber ring in Kearney; ADSL, DSL, ISDN available; dual feed from two separate switching offices available; POP in Kearney

Highways.....	Direct Access from Interstate 80, Exit 275 from Cherry Avenue, direct access from U.S. Highway 30 (4-lane) serves building
Railroads.....	Union Pacific Railroad; main line serves Kearney
Air Service	Kearney Regional Airport; Great Lakes Airlines with multiple direct 1-HR inbound and 1-HR outbound flights to Denver International Airport (DIA)
